LRA BAC-INFRASTRUCTURE RESOLUTION NO. 2022-01

RESOLUTION DECLARING FAILURE OF THE REPAINTING OF WALLS, INSTALLATION OF LAMINATED FLOORING, INSTALLATION OF DROP CEILING AND INSTALLATION OF ADDITIONAL LIGHTS, OF FINANCIAL SERVICE VIA SMALL VALUE PROCUREMENT

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee on Infrastructure (BAC-Infra), pursuant to the provisions of Republic Act 9184 (Procurement Law) and its Implementing Rules and Regulations, and related guidelines, invited contractors to submit a quotation for the Repainting of Walls, Installation of Laminated Flooring, Installation of Drop Ceiling and Installation of Additional Lights, of Financial Service;

WHEREAS, the request for quotation was made through small value procurement;

WHEREAS, HGW=3 Engineering Construction is the lone bidder for the aforementioned procurement, the deadline for the submission and receipt of bids was on June 9, 2022 at 4:00 pm;

WHEREAS, upon evaluation by the TWG, it appears that the BAC Secretariat posted, along with the Request for Quotation, the agency's budget costing and bill of quantities in the Philgeps website;

WHEREAS, also upon evaluation by the Technical Working Group (TWG), HGW=3 Engineering Construction submitted its Bid Proposal that is exactly the same with the Approved Budgetary Cost (ABC) and the Bill of Quantities (BOQ);

WHEREAS, Section 41 of the revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 provides that the HOPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations: (b) If the BAC is found to have failed in the following the prescribed bidding procedures;

NOW, THEREFORE, in view of the foregoing, the Bids and Awards Committee on the Infrastructure (BAC-Infra), RESOLVE, as it is hereby RESOLVED, to:

- To declare a failure of bidding for the Repainting of walls, Installation of Laminated Flooring, Installation of drop ceiling and Installation of additional lights, of Finance Service; and
- Conduct a reposting of Request for Quotation therefor;
