## LRA BAC-PGSM RESOLUTION No. 2022-17

(Pursuant to Approved Supplemental Procurement Plan for FY 2022)

## Declaring IRENTRADE INDUSTRIAL SALES AND SERVICES as the Lowest Calculated and Responsive Quotation (LCRQ) to LRA's Small Value Procurement for the Supply & Delivery of LRA ID LACE

WHEREAS, the Land Registration Authority, through the Bids and Award Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), pursuant to the provision under Item No. 8, Annex H of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed Php1,000,000.00, commenced the procurement for the Supply & Delivery of LRA ID LACE with an Approved Budget for the Contract (ABC) in the amount of Two Hundred Fifty Thousand Pesos (P250,000.00) which is in the LRA Supplemental Procurement Plan (SPP) for FY 2022 (Annex A);

WHEREAS, on June 20, 2022, the BAC-PGSM submitted a Request for Quotation for the said procurement project to three (3) prospective suppliers. The same was also posted on the LRA website on June 21, 2022, and on the Philippine Government Electronic Procurement System (PhilGEPS) website on June 22, 2022;

WHEREAS, Irentrade Industrial Sales & Services, Azitsorog Incorporated, Work Habits Trading, Rulujac Enterprise, and Grafiq Advertising System Corporation, were the five (5) suppliers which submitted their respective quotations in sealed envelopes within the deadline;

WHEREAS, during the meeting conducted on July 11, 2022, 02:00 pm, at the LRA Conference Room and/or Zoom, the quotations of the five (5) suppliers were opened and the BAC-PGSM ascertained the existence of all the documents required using a non-discretionary "pass / fail" criterion;

WHEREAS, per evaluation of the BAC-PGSM Technical Working Group (TWG), all suppliers passed the eligibility and technical requirements. The offer of Irentrade Industrial Sales & Services amounting to One Hundred Seventeen Thousand Five Hundred Pesos (P117,500.00) VAT Inclusive is deemed to be the most advantageous to the government as the same is the lowest calculated responsive quotation;

WHEREAS, the BAC-PGSM Members find the recommendation of the BAC-PGSM TWG in strict compliance with RA 9184 and its revised IRR.

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the Bids and Awards Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), hereby RESOLVE to:

- 1) DECLARE, through this instrument, the price quotation of Irentrade Industrial Sales & Services, as the Lowest Calculated and Responsive Quotation (LCRQ), and;
- 2) RECOMMEND to the Honorable Administrator that of Irentrade Industrial Sales & Services be awarded the contract via Small Value Procurement for the Supply & Delivery of LRA ID Lace in the amount of One Hundred Seventeen Thousand Five Hundred Pesos (P117,500.00) VAT Inclusive.
