## LRA BAC-PGSM RESOLUTION NO. 2022-66

(Pursuant to BAC-PGSM Reso. No. 2022-24)

## DECLARING NET Q COMPUTER SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OF THE SUPPLY AND DELIVERY OF 120 UNITS OF TONER CARTRIDGES FOR RICOH IM 2702 MEDIUM SIZE COPIERS

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed ₱1,000,000.00, commenced the procurement for the Supply and Delivery of 120 Units of Toner Cartridges for Ricoh IM 2702 Medium Size Copiers with an Approved Budget fo the Contract (ABC) in the amount of Four Hundred Thirty Two Thousand Pesos (₱432,000.00), VAT inclusive;

**WHEREAS,** the said procurement was posted on the LRA and PhilGEPS websites on 8 September 2022;

**WHEREAS,** before the deadline on 20 September 2022, The Value Systems Integration Inc., Net Q Computer Services; Cron Office Systems Inc., Best Choice Enterprises, submitted their respective quotations in a sealed envelope within the deadline;

**WHEREAS**, during the meeting conducted on 23 September 2022, at the Finance Service Conference Room, the LRA-BAC opened the quotations of the above-mentioned bidder:

WHEREAS, the four (4) bidders submitted the following quotations:

**WHEREAS**, per evaluation of the BAC-TWG for Non-Infra, the four (4) bidders were able to submit the prescribed quotation form with compliance to specification, however, only three among them were able to comply with the requirements as Best Choice Enterprises failed to submit the original copy of the notarized Omnibus Sworn Statement;

WHEREAS, among the four (4) bidders, the offer of Net Q Computer Services amounting to Three Hundred Sixty Thousand Pesos (₱360,000.00) VAT Inclusive, is deemed to be the most advantageous to the

government as the same is the Lowest Calculated and Responsive Quotation (LCRQ)

**WHEREAS,** the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra is in strict accordance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, We, the members of the LRA-BAC hereby RESOLVE to:

- 1) DECLARE the quotation of **Net Q Computer Services** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of Supply and Delivery of 120 Units of Toner Cartridges for Ricoh IM 2702 Medium Size Copiers to Net Q Computer Services in the amount of Three Hundred Sixty Thousand Pesos (\$\bar{P}\$360,000.00) VAT Inclusive.
