LRA BAC-PGSM RESOLUTION NO. 2022-67

(Pursuant to BAC-PGSM Reso. No. 2022-63)

DECLARING NEW A.G. STYLIST FURNITURE AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF SEMI-EXPENDABLE OFFICE FURNITURE AND EQUIPMENT (1 LOT) AND RECOMMEND THE AWARD OF CONTRACT THEREFOR

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee LRA-BAC, pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed \$\mathbb{P}\$1,000,000.00, commenced the procurement for the Supply and Delivery of Semi-Expendable Office Furniture and Equipment (1 Lot) with an ABC in the amount of Eighty-six Thousand Five Hundred Fifty-three Pesos and Fifty Centavos (\$\mathbb{P}\$ 86,553.50), VAT inclusive;

WHEREAS, New A.G. Stylist Furniture, was the only bidder which submitted their quotation in a sealed envelope within the deadline set at 9:00 AM, on 29 December 2022;

WHEREAS, during the meeting conducted on 29 December 2022, at the LRA Conference Room, the LRA-BAC opened the lone quotation of the above-mentioned bidder which was found to have full compliance to all technical specification, as well as financial specification as shown in the table below:

WHEREAS, per evaluation of the BAC-TWG for Non-Infra the lone bidder passed the eligibility and technical requirements. The offer of New A.G. Stylist Furniture amounting to **Seventy-four Thousand Five Hundred Pesos** (**P74,500.00**) **VAT Inclusive**, is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);

- RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of Supply and Delivery of Semi-Expendable Office Furniture and Equipment (1 Lot) to New A.G. Stylist Furniture in the amount of Seventy-four Thousand Five Hundred Pesos (\$\P\$74,500.00) VAT Inclusive
