DECLARING PROXIMATECH SOLUTIONS COMPANY AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OF THE SUPPLY AND DELIVERY OF TEN (10) BARCODE THERMAL PRINTERS AND RECOMMEND THE AWARD OF CONTRACT THEREFOR

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed ₱1,000,000.00, commenced the procurement for the Supply and Delivery of Ten (10) Barcode Thermal Printers with an ABC in the amount of One Hundred Sixty Thousand Pesos (₱160,000.00), VAT inclusive;

WHEREAS, on 26 November 2022, the LRA-BAC submitted Request for Quotation for the said procurement project to three (3) prospective bidders. The same is posted on the LRA and PhilGEPS websites on 26 November 2022;

WHEREAS, before the deadline on 2 December 2022, Proximatech Solutions Company, Touchmedia Supply and Services Corporation, and Pronet Systems Integrated Network Solutions, Inc. submitted their respective quotations in a sealed envelope within the deadline;

WHEREAS, during the meeting conducted on 13 December 2022, at the LRA Conference Room, the LRA-BAC opened the quotations of the above-mentioned bidder which was found to have full compliance to all technical specification, as well as financial specification as shown in the table below:
