RECOMMENDING THE AWARD OF CONTRACT FOR THE PROVISION OF SECURITY SERVICES IN THE LRA CENTRAL OFFICE AND ITS REGISTRIES OF DEEDS NATIONWIDE

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), pursuant to the provision of Republic Act No. 9184, as amended, invited bidders through posting in Philippine Government Electronic Procurement System (PHILGEPS) on 24 November 2021, and conspicuous place reserved for this purpose in the premises of this Authority for the Provision of Security Services in the LRA Central Office and Its Registries of Deeds Nationwide, with an Approved Budget for the Contract (ABC) in the amount of Forty Eight Million Nine Hundred Thirty-Seven Thousand One Hundred Thirty-Eight Pesos and Sixty-Eight Centavos (§48,937,138.68);

WHEREAS, on December 02, 2021 at 10:00 a.m., a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, and was attended by two (2) prospective bidders namely, Urduja Security Services, Inc., and Eagleone Security Services, Inc.;

WHEREAS, prospective bidders namely, Urduja Security Services, Inc., and Eagleone Security Services, Inc., purchased the bid documents;

WHEREAS, during the bid opening of bids on December 14, 2021, 10:00 a.m., at the LRA Conference Room, Urduja Security Services, Inc., and Eagleone Security Services, Inc., submitted their eligibility, technical, and financial proposals;

WHEREAS, after evaluation of the bid proposals, the following bidders were found to be eligible and complying of all the technical and financial requirements and detailed evaluation of their bid proposals, to wit:
