WHEREAS, on 30 June 2023, the Bids and Awards Committee on Infrastructure proceeded to open the bids duly submitted by the bidders in response to the call for submission of bids for the Repainting of LRA Central Office Building, Quezon City, with an Approved Budget for the Contract (ABC) in the amount of Philippine Pesos: THREE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 3,500,000.00);

WHEREAS, JAYTERKIEL BUILDERS, submitted and passed the preliminary evaluation on eligibility requirements. Thus the Technical Working Group (TWG) proceeded with the post qualification on July 5 & 6, 2023.
