WHEREAS, Section 35 and 35.1 of the 2016 Revised IRR of R.A 9184 is hereby quoted as follows:

Section 35 of the 2016 IRR of RA 9184 provides that:

"Section 35. Failure of Bidding

- 35.1. The BAC shall declare the bidding a failure when:
 - a) No bids are received x x x "

NOW, THEREFORE, We, the members of the LRA-BAC, hereby RESOLVE to:

- 1. Declare a failure of bidding for the Rental Of Outdoor Tent for LRA Central Office 2023 Year-End Party; and
- 2. Conduct a reposting of Request for Quotation therefor.
