DECLARING CRON OFFICE SYSTEMS INC. AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF TWO (2) UNITS OF A3 COLORED PRINTER

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee, pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed ₱1,000,000.00, commenced the procurement for the **Supply and Delivery of Two (2) Units of A3 Colored Printer with an ABC in the amount of Ninety-Nine Thousand Nine Hundred Ninety-Eight Pesos (Php 99,998.00)**, VAT inclusive;


