DECLARING CCP COMPUTER TECHNOLOGIES INC. AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF 27 UNITS OF BAR CODE THERMAL PRINTER AND 81 ROLLS OF VELERON STICKER

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the Supply and Delivery of 27 Units of Bar Code Thermal Printer and 81 Rolls of Veleron Sticker with an ABC in the amount of Five Hundred Thirty-Seven Thousand Three Hundred Pesos (Php 537,300.00), VAT Inclusive;

WHEREAS, the said procurement was posted on the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 17 May 2023;

WHEREAS, before the 22 May 2023 deadline, two (2) sealed envelopes were received by the BAC-Secretariat for Non-Infra.

WHEREAS, the two (2) sealed envelopes were consecutively opened and presented during the LRA-BAC meeting, called for the purpose, on 09 June 2023 at the LRA Conference Room.

WHEREAS, the two (2) bidders submitted the following quotations:

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, the two (2) bidders were able to comply with the necessary documentary requirements and technical specifications required;

WHEREAS, among two (2) bidders, the offer of CCP Computer Technologies Inc. is deemed to be the most advantageous to the government as the same is the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations; CERTIFIED TRUE COPY:
