(Pursuant to Supplemental Procurement Programs ICT-2023-01)

DECLARING XITRIX COMPUTER CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF TWENTY (20) UNITS OF DESKTOP COMPUTERS

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php1,000,000.00, commenced the procurement for the Supply and Delivery of Twenty (20) Desktop Computers with an ABC in the amount of Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty Pesos (Php 999,980.00), VAT Inclusive;

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 30 August 2023;

WHEREAS, before the **06 September 2023** deadline, two (2) sealed envelopes from 1) Xitrix Computer Corporation and 2) Bayan PC were received by the BAC-Secretariat for Non-Infra;

WHEREAS, the two (2) sealed envelopes were consecutively opened and presented during the LRA-BAC meeting, called for the purpose, on 12 September 2023 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, only a single bidder, Xitrix Computer Corporation, was able to comply with the necessary documentary requirements and technical specifications required. Bayan PC failed on the required specifications.

WHEREAS, the single compliant bidder submitted the following quotation:

WHEREAS, Xitrix Computer Corporation submitted the sole valid quotation amounting to Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty Pesos (Php 999,980.00), VAT inclusive, which is within the ABC;

WHEREAS, the offer of **Xitrix Computer Corporation** is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Xitrix Computer Corporation** as the Single Calculated and Responsive Quotation (SCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Supply and Delivery of Twenty (20) Desktop Computers to Xitrix Computer Corporation with a submitted bid price amounting to Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty Pesos (Php 999,980.00), VAT inclusive.
