This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders, and for inclusion in the Bid Proposal to be submitted to the LRA-BAC for Non-Infrastructure (LRA-BAC Non-Infra) for the Procurement of One (1) Year Subscription of Nine (9) AutoCAD (Civil 3D) Software Licenses - Single User ELD.

These changes, revisions, modifications, or clarifications shall become an integral part of the Contract as well the Bidding Documents, and shall be taken into account in the submission of the sealed proposal.

I. The issues and concerns raised by the prospective bidders are as follows:

# Avtech Information Technology Solutions, Inc.

 Avtech Information Technology Solutions Inc. is requesting whether they can use Adobe License purchase as their Single Largest Completed Contract (SLCC).

ANSWER: The Committee resolved NOT to accept Adobe License purchase as SLCC. However, the Committee clarified that contracts similar to AutoCAD may be considered as SLCC.

## Maximum Solutions Corporation

1. Maximum Solutions Corporation inquired as to the number of bidding documents that they need to submit.

ANSWER: The Committee reiterates that all prospective bidders are required to submit only ONE (1) ORIGINAL COPY of the bidding documents indicated in the Checklist.

Maximum Solutions Corporation also requested the copy of bid supplements for the project.

ANSWER: The Bid Supplements and all documents pertaining to the Procurement Project may be accessed through the LRA Website at https://lra.gov.ph/bids-opportunities/



#### **Idenico Computer Corporation**

 Idenico Computer Corporation requested that AutoCAD (Civil 3D) in the Bid Data Sheet be changed to software license so that they may be able to join the bidding.

ANSWER: The Committee resolved NOT to adjust the minimum specifications set under Section VII Technical Specifications.

As stated by the End-User during the Pre-Bid Conference, AutoCAD (Civil 3D) is the required software license since they are already using the same software and that their personnel have undergone AutoCAD (Civil 3D) training.

#### II. LRA-BAC Non-Infra Reminders:

This Supplemental/Bid Bulletin No. 1 shall form part of the Bidding Documents and must be included in the submission of the Bid Proposal. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
