

LRA BAC-PGSM RESOLUTION NO. 2024-44

(Pursuant to Year 2024 Annual Procurement Plan)

DECLARING DEUS ENTERPRISES CO. AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF EXTERNAL HDD, FLASH DRIVE, WEBCAM AND HEADSET WITH MICROPHONE

WHEREAS, the Land Registration Authority through the Bids and Awards Committee for Non-Infrastructure (LRA-BAC Non-Infra), pursuant to the provision of Republic Act No. 9184, as amended, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed PHP 1,000,000.00, commenced the procurement for the Supply and Delivery of External HDD, Flash Drive, WebCam and HeadSet with Microphone, with an Approved Budget for the Contract (ABC) in the amount of Five Hundred Forty Thousand Three Hundred Pesos Only (PHP 540,300.00), VAT inclusive;

WHEREAS, the said Request for Quotation (RFQ) was sent to at least three (3) prospective bidders and the same was posted at the LRA and the Philippine Government Electronic Procurement System (PhilGEPS) websites on 12 July 2024;

WHEREAS, before the deadline for submission of quotation lapsed on 18 July 2024 at 4:00 PM, seven (7) quotations were received by the BAC-Secretariat for Non-Infra, namely:

- 1. Integrated Computer Systems Inc.;
- 2. DCI International Solutions & Services Corporation;
- 3. Terabit Computer Systems Corporation;
- 4. Nspire Inc.:
- 5. Pronet Systems Integrated Network Solution Inc.;
- 6. Deus Enterprises Co.; and
- 7. Bayan PC.

WHEREAS, the seven (7) sealed envelopes were consecutively opened and presented during the BAC meeting, called for the purpose, on 26 July 2024 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, only three (3) of the seven (7) prospective suppliers have successfully met all the financial and technical specifications, namely:

- 1. Deus Enterprises Co.;
- Integrated Computer Systems Inc.; and
- 3. Pronet Systems Integrated Network Solution, Inc.;

WHEREAS, Bayan PC was disqualified due to the non-submission of a copy of their Latest Income/Business Tax Return; while, Nspire Inc. was disqualified for exceeding the ABC on one of the components. Moreover, DCI



International Solutions & Services Corporation and Terabit Computer Systems Corporation were disqualified due to the non-submission of a complete quotation for all the components on the Request for Quotation;

WHEREAS, during the BAC meeting, the following result was obtained:

WHEREAS, among the three (3) qualified suppliers, Deus Enterprises Co. is the lowest quotation submitting a total quotation in the amount of Four Hundred Fifty-Three Thousand Two Hundred Ninety-Three Pesos Only (PHP 453,293.00), VAT Inclusive, which is within the TOTAL ABC

WHEREAS, based on the submitted Price Quotation Form, the "actual sum of prices of component items" offered by Deus Enterprises Co. is in the amount of Four Hundred Fifty-Five Thousand Five Hundred Ninety-One Pesos Only (PHP 455,591.00), VAT Inclusive, which is within the TOTAL ABC.;

WHEREAS, Sec. 32, Sec. 32.2, and Sec. 32.2.3 of the 2016 Revised IRR of RA 9184 provides that:

Section 32. Bid Evaluation for the Procurement of Goods and Infrastructure Projects

XXX

32.2 For the procurement of Goods and Infrastructure Projects, the BAC shall evaluate the financial component of the bids to determine the Lowest Calculated Bid using the following steps:

Xxx

32.2.3 In case of discrepancies between: (a) bid prices in figures and in words, the latter shall prevail; (b) total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; (c) stated total price and the actual sum of prices of component items, the latter shall prevail; (d) unit cost in the detailed estimate and unit cost in the bill of quantities, the latter shall prevail. [Emphasis supplied];

WHEREAS, in accordance with the foregoing provisions, the "actual sum of prices of component items" submitted by Deus Enterprises Co. in the

amount of Four Hundred Fifty-Five Thousand Five Hundred Ninety-One Pesos Only (PHP 455,591.00), VAT Inclusive, shall be used for bid evaluation purposes.;

WHEREAS, Sec. 34.4 of the 2016 Revised IRR of RA 9184, on the other hand, provides that the award of contract shall be based on the submitted bid price or the calculated bid price, whichever is lower. Consequently, the submitted price of Four Hundred Fifty-Three Thousand Two Hundred Ninety-Three Pesos Only (PHP 453,293.00), VAT Inclusive, shall be the basis of awarding the contract.

WHEREAS, the offer of Deus Enterprises Co. amounting to Four Hundred Fifty-Three Thousand Two Hundred Ninety-Three Pesos Only (PHP 453,293.00), VAT Inclusive is deemed to be the most advantageous to the government as the same is the Lowest Calculated and Responsive Quotation (LCRQ).

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the LRA-BAC Non-Infra, hereby RESOLVE to:

- 1) DECLARE the quotation of **Deus Enterprises Co.** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Supply and Delivery of External HDD, Flash Drive, WebCam and HeadSet with Microphone in the amount of Four Hundred Fifty-Three Thousand Two Hundred Ninety-Three Pesos Only (PHP 453,293.00), VAT inclusive.
